August 23rd – Radke Regional Park Arena, Martinez, Ca

Rules:

- 1) You must pay a one-time \$10 registration fee.**
- 2) You must compete in 2 out of 3 of the shows to qualify for the Buckle Series.**
- 3) There shall be 6 buckle series award categories:**

• English 17 & under	• English 18 & over
• Western 17 & under	• Western 18 & over
• Ranch 17 & under	• Ranch 18 & over

4) Each show establishes the classes that make up these categories. These classes may vary from show to show. Refer to the individual show rules for further details.

5) Points are accrued based on a horse/rider combination and are not transferable to another combination.

6) The combination with the highest point totals of 2 out of 3 shows will be used to determine the Buckle Series champion.

7) There must be a minimum of 2 qualified combinations per category competing in order to receive the series award.

8) Ties will be broken by random draw.
